En concreto el pasado día 5 de Abril se publicó en el diario El Confidencial un artículo¹¹ al que se adjuntaba documentos relacionados con la operativa aquí reconstruida. El primero de estos documentos, que se adjunta al presente informe como ANEXO 5, recoge una carta destinada al departamento de cumplimiento normativo de la entidad bancaria suiza Credit Suisse en el que Ramses OWENS, manager de la entidad MOSSFON TRUST, confirma que, a 15 de febrero de 2008, Gabriela DE LA ROSAL MISOL era la beneficiaria última de la sociedad BARCEM LTD.

SERVICE AND ASSISTANCE AGREEMENT**

THIS AGREEMENT is entered into by and between

1. Ard-choille B.V., a private limited liability company ("besloten vennootschap met beperkte aansprakelijkheid"), duly incorporated under the laws of the Netherlands, registered with the Chamber of Commerce in The Hague, The Netherlands, under number 27178047, having its registered office at Alexanderstraat 23, 2514 JM The Hague, The Netherlands, duly represented for the purpose of this agreement by it's sole director ITPS (Netherlands) BV, acting in its capacity of director (hereinafter referred to as "Ard-choille");

and

2. Barcem Ltd., a limited liability, duly incorporated under the laws of the British Virgin Islands, having its registered office at Akara Bldg. 24 De Castro Street, Wickhams Cay I, Road Town, Tortola, British Virgin Islands, duly represented for the purpose of this agreement by it's sole director Mossack Fonseca & Co (B.V.I) Ltd., (hereinafter to as "The Consultant").

WHEREAS :

- (i) Ard-choille has entered into a Financial Advisory Services Agreement (hereinafter referred to as "Master Agreement"), as attached, with Sun Capital Partners Limited, a company incorporated under the laws of England and Wales, under registration number 4222797, with its registered office at Watson House, 54 Baker Street, London, W1U 7B4, United Kingdom (hereinafter referred to as "Sun Capital"), to assist and advise Sun Capital in connection with the identification and conception of investment opportunities for institutional investors and all other services related as identified in the attached Master Agreement
- (ii) The Consultant renders consultancy services to institutional investors that wish to invest in real estate in Spain
- (iii) Pursuant to the Master Agreement Ard-choille wishes to sub-contract part of the services it has to render under the Master Agreement to the Consultant which the Consultant wishes to provide
- (iv) In its letter of 5 March 2008, as attached, Sun Capital has authorized to delegate the provision of the Services under the Master Agreement
